### FINANCIAL GUARANTEE

United States Citizenship and Immigration Service (USCIS) regulations require documentation that sufficient financial resources are available to meet a student’s prospective educational and living expenses while in the U.S. Therefore, Texas A&M University-Texarkana requires a guarantee of financial resources from each applicant who expects to obtain or maintain Student (F-1) status. Applicants are required to submit financial documentation that equals or exceeds one full year of expenses, for the program of study in which they are interested. Changes in the below financial certification cannot be adjusted based upon a student’s individual circumstances. The estimate is based upon enrollment in 12 semester credit hours each semester for undergraduate studies and 9 semester credit hours each semester for graduate studies.

*Please note: This estimate is based on 12 credit hours per semester for non-resident tuition. Students who must enroll in at least 15 credit hours to obtain or maintain certain scholarships may have higher costs than those shown.*

**A Certificate of Eligibility (I-20) will not be issued until this information is provided.**

Scholarships available to international students at Texas A&M University-Texarkana are limited **and students should not rely on scholarship funds to finance their educational costs.** Contact the scholarship office at [scholarships@tamut.edu](mailto:scholarships@tamut.edu) for more information regarding scholarship opportunities available at A&M Texarkana.

The amounts listed below are estimates determined by the actual cost figures for the academic year. The amounts below are subject to change without notice.
